

The American Legion Riders Association of Wisconsin, Legacy Scholarship Fund Sweepstakes
OFFICIAL RULES

1. **ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE.** Making a donation to The American Legion Riders Association of Wisconsin will not improve your chances of winning. Sweepstakes is void in New York and Florida or where otherwise restricted or prohibited by law. To enter The American Legion Riders Association of Wisconsin Sweepstakes (the "Sweepstakes"), you: (i) must be a citizen of the United States or a lawful permanent resident of the United States; (ii) must be 18 years of age or older at the time of entering the Sweepstakes; and (iii) must not be considered a minor in your state of residence. Page St. Stoughton WI 53589. The selected winners will be notified by Sponsor via telephone, mail or the email address supplied during entry at Sponsor's sole discretion. The odds of winning depend on the number of eligible entries received. The Sponsor's decisions are based on its sole discretion and interpretation of these official rules, and are final and binding in all respects. If a potential winner does not respond to the prize notification within ten (10) business days from the first notification attempt, then such entrant will be disqualified and an alternate winner will be selected.
